

## ADDITIONAL TECHNICAL INSTRUCTIONS

1. Companies participating with a stand without a structure (**TYPE 1**) their exhibition space will be provided on Tuesday 05/02/2019 for the construction of the stands.
2. Companies participating with standard structure (**TYPE 2**) their exhibition space will be provided on Wednesday 06/02/2019 after 08:00 am.
3. Every constructional work must be completed and all exhibits must be placed by Friday 08/02/2019 until 14:00 pm.
4. Exhibitors can dismantle/remove the stands on Tuesday 12/02/2019 and Wednesday 13/02/2019 from 08:00 am until 21:00 pm. During the dismantling/removal of constructions and exhibits there should be present a representative of the company in your stand for a smooth procedure to be ensured. As the organizing company, we have no responsibility during the dismantling process for the security of exhibits and materials.
5. During construction and dismantling period, it is advisable not to place boxes or heavy objects in the corridors that prevent the smooth process of the works overall.
6. There is a limitation of 50 cm between all the stands and the corridors surrounding them (it would be wise to avoid the placement of exhibits).
7. The maximum height of the stand must be 30 cm lower than the ceiling of each respective pavilion (maximum 4.50 m) and width of 1,00m.
8. Constructions should be self-supported and the locations with **Fire Hose Cabinets and electrical panels should be visible and easily accessible from all.**
9. Exhibitors are required to cover and paint the perimeters of the stands, especially if they exceed the height of 2,5 meters.
10. In each stand, the placement of two (2) self-supported pylons (totems) or alternatively two (2) self-supported panels for the display of the exhibitor's logo is allowed.
11. Artificial flooring must not be more than 20 cm from the ground at any point, as well as having a ramp for the disabled.
12. The lowest point for lighting fixtures is not allowed to be less than 2,5m from the floor of the stand.
13. From column No 31 to column No 54, the maximum total weight (stands and exhibits) should not exceed 200 kg/m<sup>2</sup>
